1. New FAA Registration Marking Requirements

EFFECTIVE Feb. 25th 2019: ALL MODEL AIRCRAFT MUST HAVE THE FAA REGISTRATION NUMBER ON THE OUTSIDE OF THE AIRCRAFT

Recently the FAA issued an Interim Final Rule requiring that all drone and model aircraft pilots legibly display their FAA registration number on the exterior of their aircraft effective February 25th. There is no requirement for where on the aircraft or how large the registration number must be, only that it be legible upon "close inspection".
